# Background

- Disaster situation and impact of climate change
- Capacity building for community to improve disaster response ability
- To increase sustainability of program and project related to disaster by combination between construction and non construction solution
- International cooperation, overseas support

## Background of governmental project

- Name: Public awareness raising and community based disaster risk management (CBDRM)
- **General goals:** public awareness raising and organize CBDRM model successfully for all levels and sectors, especially local government and citizens at village and commune.
- Scope of implementation: 6.000 affected commune by disaster.
- **Implementation period**: 2009 2020
  - □ Phase 1 (2009 2010)
  - ☐ Phase 2 (2011-2015)
  - □ Phase 3 (2016 2020)
- Tentative budget: 988 billion VND

# Specific goals of project:

- Complete mechanism and policy on CBDRM through national to local level;
- Enhance capacity for officers at all level who are working in storm and flood control, disaster management
- Villages and communes located in high vulnerability of disaster can develop disaster prevention plan, communication systems and warning systems. Set up key team and volunteers.
- Community: 70% affected communes has been propagated knowledge on flood and storm control and DRR;
- Integrate knowledge on DRR into school.

## Content of project:

Component 1: Capacity building for officers at all level about CBDRM implementation and management.

Ensure 100% officers at all levels working in CBDRM to be trained, capacity building on CBDRM

Component 2: Strengthen communication, education and public awareness raising on CBDRM



Improve knowledge for community on disaster reduction; more than 70% people in affected commune is propagated about storm and flood control, DRR.

## Component 1:

- Develop law document, guideline about management and implementation CBDRM.
- Complete disaster prevetion and management systems of all line agencies at all levels.
- Develop training systems on CBDRM.
- Organize training coures for trainer (ToT training) for organizations, local officers and staff related to implement CBDRM at all level.
- Improve, upgrade and construct new center office for flood and storm control, DRR at provincial level.

## Component 2:

- Establish action team to implement CBDRM project
- - Develop disaster risk and vulnerability map at each community. Collect and update information for disaster risk and vulnerability map.
- Handbook for guiding activities implementation of community about preparation, response and recovery correlative to disaster period: before, during and after disaster for each community.
- Community develops annual plan for disaster prevention, preparedness and management with integration CC.
- Community establishes development plan with integration disaster risk reduction.
- Develop practical systems about DRR annually

## Component 2 (cont):

- Establish warning systems, early communication for disaster in community.
- Set up evaluation systems and monitoring on activities DRR in community.
- Activities on CBDRM are propagated through Web, television, newspaper and panel, poster....
- Develop training curriculum on DRR
- Organize training workshop for community with many targeted obect.
- Organize shows, drama about DRR in community in celebrated day.
- Build small construction supporting to DRR in community.

## Target and solution to disaster risk reduction in Mekong basin

## **Target:**

"Living with flood" ensures sustainable development; disaster risk reduction actively, storm, flood, drought, salt intrusion...

## Target and solution to disaster risk reduction in Mekong basin

#### **Solution:**

- Planning storm and flood control;
- Exploit the advantageous aspect of flood;
- Increase investment on channel system, drainage channel, dyke, transportation, community and infrastructure;
- Capacity building for officers in disaster management;
- International cooperation between nation in Mekong basin to exploit sensibly, water resources protection and CCA.

# Project budget

#### Total investment: 989 billion VND

- Component 1: capacity building for local officer at all levels, implement annual activities in CBDRM: 183 billion VND.
- Component 2: enhance ability for community on CBDRM: 806 billion VND.

#### Source of capital:

Tentative budget for project:

- National budget: 547 billion VND (55%)
- Inhabitant budget: 46 billion (5%)
- Funds from international governments and NGOs: 395 billion VND (40%).

#### Implementation and investment period:

- Phase 1 (2009-2010): 75 billion VND
- Phase 2 (2011-2015): 367 billion VND
- Phase 3 (2016 2020): 547 billion VND
