REPORT COVERING THE FIRST NATIONAL COURSE ON GOVERNANCE AND DISASTER RISK REDUCTION 3-6 June 2008, Sulo Hotel Quezon City

The First National Course on Governance and Disaster Risk Reduction was held on 3-6 June 2008 at the Sulo Hotel, Quezon City. The Course is one of the last activities of the PROMISE-Philippines Project. The Course is a customized version of the Regional Course designed and facilitated by the Asian Disaster Preparedness Center-Urban Disaster Mitigation Team together with the five PROMISE country partners. The First National Course is also a customized version of the First LGU Course on Governance and Disaster Risk Reduction in Dagupan City conducted by PROMISE-Philippines on 8-10 April 2008.

Course Objectives

The general objectives of the First National Course on Governance and Disaster Risk Reduction were:

- 1. To strengthen the capacity of local government officers in disaster risk reduction (DRR) and
- 2. To provide the framework and tools in integrating DRR in local governance.

At the end of the course, the participants were expected to be able to:

- 1. Explain basic concepts in disaster risk management and governance
- 2. Describe framework for integrating disaster risk reduction in development planning and implementation
- 3. Explain applicable strategies, methods and tools in risk sensitive development planning and implementation
- 4. Relate experiences and practice shared in integrating disaster risk reduction in local governance to applications in back to workplace/local conditions

To meet these objectives, the course was divided into 3 course modules with 12key sessions.

- Module 1 Framework and Challenges in Disaster Risk Reduction and Development
- Module 2 Risk Sensitive Spatial and Sectoral Planning and Development
- Module 3 Learning from Good Practice Study Visits
