# **B:** Executive Summary

# ECHO support to MRC Flood Mitigation and Management Program

The European Union is the world's largest provider of financing for humanitarian aid operations. Altogether, the European Commission in Brussels and the governments of the 27 Member States pay for more than 50% of the assistance that comes from official channels. The European Commission itself is responsible for managing almost half of this aid. In 2006, the Commission provided €671 million for humanitarian projects in more than 60 countries, funding relief to millions of victims of disasters outside the European Union.

Within the Commission, operations are masterminded by the Humanitarian Aid department (ECHO) which comes under the responsibility of Commissioner Louis Michel. Operations include assessment of humanitarian needs in disaster areas, appropriate allocation of funds for goods and services such as food, shelter, medical provisions, water supplies or sanitation and evaluation of the impact of the aid provided. The Mekong River Commission Secretarial (MRC) through its National Mekong Committees (NMCs) and in collaboration with the Asian Disaster Preparedness Centre (ADPC) has been implementing the project on **Planning and Implementation of Flood Preparedness Programs** in Cambodia, Lao PDR and Vietnam with funding support from European Commission Humanitarian Department (ECHO) under the overall framework of the Component 4 of the MRC's Flood Management and Mitigation Program (FMMP). This project since 2003 is being implemented with support the National Mekong Committees (NMCs) as well as the National Disaster Management Offices (NDMO) through its provincial and district Disaster Management offices of these three riparian countries in the lower Mekong Basin.

The Phase I project "Implementation of Flood Preparedness Programs at Provincial and District Levels" was implemented by MRC and ADPC under the 3rd DIPECHO Action Plan for South East Asia during September 2003 - June 2004 and involved capacity building for flood preparedness planning and response through the use of flood information products by MRC in the countries of Lower Mekong Basin, namely; Cambodia, Lao PDR, Thailand and Vietnam.

Similarly, the Phase II of the project titled "Capacity Building for Planning and Implementation of Flood Preparedness Program at Provincial and Districts levels in the Lower Mekong Basin" was implemented under the DIPECHO 4th Action Plan for Southeast Asia during February 2005- April 2006. During 2007-2008, Phase III of the project "Support to Implementation of Flood Preparedness Programs at Provincial, District and Commune Levels in the Lower Mekong Basin" was implemented under the DIPECHO 5th Action Plan for South East Asia aiming to enhance capacities to prepare and implement flood preparedness programs at the provincial, district, and commune levels in the target provinces of Cambodia, Vietnam, and Lao PDR.

During the Phase III, the focus in Lao PDR were to conduct one provincial level training course for the Khammouane Provincial Disaster Management Committee (PDMC) and support to the Nongbok District Disaster Management Committee (DDMC) in Khammouane province in preparation of the district flood preparedness program.

Based on the lessons learnt from successful implementation of these previous three phases and recommendations received from the national, provincial and district level authorities, MRC and ADPC have now initiated the Phase IV project on "Strengthen Implementation of Flood Preparedness Program at National, Provincial, District and Commune Levels in the Lower Mekong Basin", being implemented during under the 6th DIPECHO Action Plan for South East Asia and continuous funding support from the European Commission Humanitarian Department (ECHO) by intensifying existing activities in Cambodia, Vietnam and Lao PDR and expanding experiences in more target areas.

### Activities and Achievements under the current Action (phase IV)

Under the Phase IV, the focus in the 3 target countries were to strengthen the selected Provincial and District Disaster Management Committees in preparation and implementation of Flood Preparedness Program and integration into the planning development process, to develop capacity of district trainers to conduct training on Flood Preparedness for the Commune Committees/Teams as well as to raise public awareness on flood risk reduction. The target districts in this phase include:

Cambodia: Kratie, Sambour, Chhlong districts in Kratie Province

Svay Chrum district in Svay Rieng Province

**Vietnam:** Cai Be, Cai Lay and Chau Thanh districts in Tien Giang Province

Cho Lach in Ben Tre Province

**Lao PDR:** Nong Bok and Xenbangfai districts in Khammouane Province

Under the phase IV project in Vietnam, the following activities were to be taken up for implementation:

- 1. Support Provincial and District Flood and Storm Control Committee of Ben Tre province and Cho Lach District in adapting the recent Government Guideline on Disaster Preparedness (Sổ tay Hướng dẫn Phòng tránh Thiên tai) issued by CCFSC and build their capacity to implement flood and storm control plans ( Act. 1.3)
- 2. Conduct refresher Training of Trainers (ToT) for the District Level Trainers on Flood Preparedness in Tien Giang province and ToT in Ben Tre province, enabling them to conduct commune level trainings in their target districts of Chau Thanh, Cai Be, Cai Lay, and Cho Lach (Act. 3.2)
- 3. Support to conduct one Commune-level training, on Flood Preparedness for the Commune DM Committees/Teams by the trained trainers in each of the selected districts in Ben Tre and Tien Giang provinces (Act. 3.3).
- 4. Consultation with provincial and district authorities as well as DIPECHO partners to review existing IEC materials (SFSP kits) and strengthen partnerships for IEC programs for specific hazards in the target provinces in Vietnam, Cambodia and Lao PDR (Act. 4.1).
- 5. Promote School Flood Safety Program (SFSP) through the Department of Education to conduct activities in 50 Schools in Tien Giang and Ben Tre province (Act. 4.2).
- 6. Documentation of good practices on Flood Management and Mitigation in the Lower Mekong Basin (Act.5.1).
- 7. Conduct one National Flood Forum before the MRCS annual flood forum (Act. 5.2).

# Additional notes on the institutional organisation for the implementation of phases IV of the project in Vietnam

In *Viet Nam,* roles and responsibilities are clearly defined in a much better institutional system of provincial and district committees for storm and flood control. Since the endorsement of the National Strategy for Disaster Prevention, Response and Mitigation to 2020, a national legal framework is available. However, implementation of the strategy is not yet fully geared up. There have been some initiatives through the NDMP as well as national advocacy through the DIPECHO Advocacy Network Initiatives (DANI) and Joint Advocacy Network for Initiatives (JANI), but there has so far been little focus on the Mekong Delta. Similarly, at the provincial and district levels, the flood and storm control plans are prepared, reviewed and updated on an annual basis, However, implementation of priority activities by the DM committees is limited due to the capacity of people at the provincial and district levels as well as lack of resources. There are a number of specific priority areas implemented during Phase III of the MRC-ADPC project and by other DIPECHO partners.

# C: Project Planning and Start Up Meeting

### Project Start up Meeting with National and Provincial level

A two-day meeting between the project team and country partners, at both national and provinces levels, such as VNMC, DDMFSC, and target provincial officials for starting up the project was held on 23-24 September 2009 in Ho Chi Minh city. Special representatives from GTZ (donors of other linked project under the Component 4) of the FMMP, MRCS/FMMP, Ministry of Culture and Information and Vietnam Red Cross were also in attendance in order to share information



and find possible solutions in cooperating the project implementation. Please see the list of beneficiaries for the meeting participants.

The meeting was focused on the following key issues:

- > to present the ECHO IV project activities (under approval from ECHO for funding) and share the implementation details
- > to look for possible solutions of cooperating the both Component 4 projects and other partners' projects into the implementation;
- ➤ to sustain the project activities into the National Strategy for Disaster Prevention, Response and Mitigation to 2020; and
- ➤ to identify roles and responsibilities of the key partners including VNMC, DDMFSC, provincial CCFSC of the target provinces and ADPC in the implementation of the project.

All partners including VNMC, DDMFSC and target provinces were satisfied and agreed with the proposed project activities as well as committed full cooperation during the implementation. Some of the discussion was agreed as;

o The PCFSCs were to be the main focal point for activities under the field implementation stage. The DDMFSC will also be the key technical partner who provides guidance and technical supports throughout the project implementation in order to assist the project implementer, as it is the role of ADPC to link with the relevant activities of the Government programs/projects and other organizations, and obtain the project goals and objectives while VNMC will act as the overall coordination role to link up responsible agencies from national down to district levels,

- o Roles and responsibilities of other partners were also widely agreed upon by participants, but the presentation of these different roles could be clarified in terms of the overall structure; ADPC agrees to develop a suitable diagram.
- VNRC has committed to proactively engage in the Training of Trainers (ToT) activities. As the VNRC has already developed relevant ToT capacities, it is able to implement training courses under these projects.
- Sustainability is a crucial outcome of these phases, and beneficiaries should be able to implement the activities.
- o Integrating project objectives with the National Strategy (2007-2020) objectives, and integration of Flood Control Plan with development planning, should be further explored, especially at the commune and village levels. Training is a key factor for integrating disaster management into local development planning.

#### Project implementation meeting with provincial partners:

While the Partnership Agreement for the implementation of the Component 4 projects was being drafted, two one-day meetings with the provincial and district partners included other related agencies e.g. Education and Training Department, Red Cross etc. were held on 8 February 2009 in the target provinces in order to:

- Introduce the project activities and discuss its implementation plan to provincial and district partners;
- Seek agreement of the implementation plan; and
- Provide further input and clarification for the above-mentioned Partnership Agreement.

(See Annex 3.C.1 and 3.C.2: Ben Tre and Tien Giang implementation meeting reports).

#### The project implementation arrangement

In order to strengthen the project implementation arrangement as well as create more favourable conditions for the field implementation in the future, MARD has promoted Mrs. Nguyen Thi Luan to be Vice Director of DDMFSC and nominated as the focal point for the project implementation based in DDMFSC Ho Chi Minh office. In the meantime, VNMC nominated Dr. Nguyen Anh Duc replacing Mrs. Nguyen Thi Hong Phuong at National FMMP Coordinator position.

By then, both VNMC and DDMFSC extended a letter to target provinces in order to officially introduce the ADPC project team and the project implementation plan to provincial agencies. A Partnership Agreement for implementation of the FMMP Component 4 projects has been cleared and signed by VNMC, DDMFSC and MRCS/FMMP, ADPC in following. This Agreement is attached herewith for reference.

- 1. Reviewed and updated Provincial and District Flood and Storm Control Plans;
- 2. 4-day training curriculum on development and implementation of the Flood and Storm Control Plan; and
- 3. Reviewed and updated Provincial Action Plan of Implementing the National Strategy of Natural Disaster Prevention, Mitigation and Response to 2020.

#### 1. Reviewing provincial and district FSC plans

The review of previous yearly FSC Plans and development of the coming year FSC Plan has been in place through the disaster management system for a long time. Traditionally all levels from the provincial to commune levels have to prepare the yearly FSC plan at the period before the rainy season as a requirement. The provincial FSC Plan integrates all district level plans into one. Therefore review of the provincial FSC Plan also means reviewing the district FSC Plan too. Taking this opportunity, the project caught up a Provincial FSC Plan Meeting to support the provincial and districts CCFSC to review a 2008 FSC Plan and develop the 2009 FSC Plan.

The Ben Tre Provincial FSC Plan Review Meeting was held in May 2009 with the participation of 37 representatives from its 28 PCFSC members and 9 DCFSCs . The main points talked about were:

- Reviewing and building upon lessons learnt from the implementation of the 2008 FSC Plan
- Developing the 2009 FSC Plan.
- Review the linkages of the yearly FSC plan to the existing Provincial Action Plan of the implementation of the National Strategy.
- Identifying the needs for training key officials in development and implementation of the FSC Plan.

The discussion and issues raised in the meeting contributed to helping provinces and districts manage flood and storms effectively in according with the recent natural disasters, inline with the guidelines of the government such as; Guideline on Disaster Preparedness, and; the National Strategy of Natural Disaster Prevention, Mitigation and Response to 2020. Furthermore, weak points in the current implementation of the FSC plan, and training needs in the development and implementation of the provincial FSC Plan were also clearly identified. Assessment of natural disasters, identification of specific objectives, identification of measures and development of relevant work plan or projects, assessment of role and responsibility, orientation of the government for disaster management were discussed during the open debate.

# 2. A 4- day training workshop on the development and implementation of the FSC Plan

Linking up of the annual FSC plan into the Provincial Action Plan is as a fundamental factor contributed to the successes of both the implementation of the annual FSC Plan and Action Plan. As identified as the gaps during the Provincial FSC Meeting, a 4-day training-workshop on the implementation of FSC Plan and Action Plan to the 77 key officials of the responsible agencies who are the members of the provincial



Ben Tre PFSC and its 9 DCFSCs, and some from An Giang and Dong Thap, were held on 9-

12 June 2009 in Ben Tre city of Ben Tre province. The objectives of the training-workshop were:

- ➤ To build capacity of PCFSC on Flood and Storm Control planning and implementation;
- ➤ To detail out the existing Provincial Action Plan and promote relevant cooperation with line agencies;
- ➤ To support CFSC members to prepare their departmental plans as per the national guideline.

The workshop-training was closely consulted with the Secretariat of the Central Committee for Flood and Storm Control and its NDMP Secretariat to implement the Vietnam National Strategy for Disaster Prevention, Response and Mitigation 2020. A cost-share approach between the project and NDMP were applied as one of the successful models that the project has obtained. The workshop-training was facilitated by a national consultant under CCFSC, a Vietnam Red Cross trainer and the three provincial SFSC officials from other Cuu Long Delta provinces e.g. Tien Giang, An Giang and Dong Thap in order to share their experiences in implementation of the both annual FSC plan and Action Plan.

There were 3 main kinds of materials used as reference for workshop-training e.g. government's guideline of disaster management (Hand Book of FSC, the national strategy of disaster management, provincial and district FSC plans), training materials developed by the pervious phases of ECHO and GTZ-funded projects, and other relevant projects in the Mekong delta.

The training curriculum was developed into 2 key parts:

- 1) Consultation on National Strategy and Provincial Action Plan for implementation of Flood and Strom Control Planning
- 2) Training on flood and storm control.

Part one is used for managers whereas Part two for the technical staff who directly prepare and carry the FSC plan. Outline of the workshop-training Curriculum is described below:

The training was divided into 2 periods, the first lasting for one day and the second lasting for the remaining three days.

 The first day of the training was a special day as it was joined by all including local persons, provincial, national and regional partners, consultant, trainers and facilitators. Experince of preparing and implementation of the provincial action plans of implementation of the national stratery was shared by the owner of Ben Tre and the neighbor provinces of Tien Giang, An Giang and Dong Thap. The national consultant and national partner of DM also gave comments and suggestion on the provincial action plan. According to the comments and suggestions, the key items that need to be done for the plan were to make it more detailed and specific, especially for the mitigation measures section and relevant projects/program of implementing these meassure.

On the first day, the activity of 'working groups' had meaningful contribution to the province in term of how to prepare and implement well the provincial action plan in according with the national stratergy (<u>Annex 3.D.1</u> - Discussion notes of Ben Tre Provincial Training).

While the remaining of 3 days focused on FSC planning technique, a participatory approach was applied. The participants joined in big and small working groups and presented their discussion. For practice of FSC and training skills, they took part in a field trip to have a district level meeting of learning the process of FSC by using the lesson learned from the workshop.

The training was also introduced broadly to public via the Newsletter of NDMP under CCFSC. Further information can be reached at <u>Annex 3.D.2</u> – Newsletter of Ben Tre Provincial Training.

In conclusions, according to the participants recommendations the 3 days was not enough, anyway, the training provided them basic knowledge and platform to shared experience of FSC and helped them be more confident and know how to find their own way for prevention, response and mitigation for the natural disasters.

With the cost-sharing approach mentioned above, it was shown that the activity had a special meaning to the province in meeting its need of capacity building as the project helped not only to strengthen a single district, but to strengthen the network of the system of districts of the province. It was one of the ways of the sustainable development in accordance with the orientation of the national strategy.

# 3. Reviewing Ben Tre Provincial Action Plan for the implementation of National Strategy 2020

In middle of 2008, Ben Tre province completed its provincial action plan for implementing the national strategy according to the guidance given by CCFSC. However, the development of the provincial action plan proved to be a very challenging task because the

current capacity of the PCFSC of Ben Tre was limited. So it could see that with the 2 reasons made the quality of the plan was little less than originally intended. Reviewing the plan for a better one was an important need of the province for that period.

Following the recommendation given by participant at the end of the above-mentioned workshop-training, a review and update of the provincial action plan was completed in December 2009 in close cooperation with the provincial CFSC members and the World Bank-funded project.

There were the two meetings conducted among the Ben Tre Provincial CFSC members in November and December 2009 in order to I) review the content of existing provincial action plan; II) to draw outline of the updated provincial action plan; and III) to finalize and endorse the updated plan.

During the meetings, gaps and weak points of the existing action plan, especially the linkages with the social-economic development plan, were clearly shown out and identified by the Provincial CFSC through facilitation from the CCFSC official and the ADPC project team. At the same time, the roles and responsibilities of the members of the provincial and districts CFSCs as well as of the society organization in the implementation of the action plan were reviewed and updated too.

# • Activity 3: Support target districts in capacity building Commune DM committee on Flood Management and Mitigation.

Activity 3.2: Conduct refresher Training of Trainers (ToT) for the District Level Trainers on Flood Preparedness in Tien Giang province and ToT in Ben Tre province, enabling them to conduct commune level trainings in their target districts of Chau Thanh, Cai Be, Cai Lay, and Cho Lach

#### Achievements of Activity 3.2:

- 1. Resource persons network for all 4 project target districts developed.
- 2. Two ToT training held for total of 37 resource persons
- One refresh ToT for 12 persons from Cai Be and Cai Lay districts in Tien Giang.
- One new ToT for 25 persons from Chau Thanh district in Tien Giang and Cho Lach district in Ben Tre.
- 3. ToT curriculum developed and adapted.

Based on a series of consultations, working group meetings (between the MRC-ADPC project team and DDMFSC southern office, the Tien Giang and Ben Tre Provincial Committee for Flood and Storm Control (PCFSC) as well as other partners such as JANI members, World Bank, etc) and the lessons learned from the numbers of ToT trainings conducted in Cuu Long Delta, the ToT curriculums developed under the previous phases of ECHO and GTZ-funded projects were reviewed and adapted to the Tien Giang and Ben Tre provincial levels focusing on flood preparedness, response and mitigation. The training curriculums were finalized and produced in two sets. The 1st set is used for the refresher ToT to the two target districts, Cai Be and Cai Lay, in Tien Giang, targeted since the Phase III, it consists of 3 key modules:

Module 1: National and provincial strategy orientations on disaster management.

Module 2: Commune flood and storm control preparedness.

Module 3: Training skills.

And another curriculum is now used for the new ToT of the two new districts identified by this phase (Chau Thanh in Tien Giang province and Cho Lach in Ben Tre province). This curriculum consists of six key modules:

Module 1: Enhance understanding of national and provincial guidance/strategies

Module 2: Understanding Disaster Management Concepts

Module 3: Flood Preparedness Planning

Module 4: Flood and Strom Control Planning at Commune level

Module 5: ToT Methods – How to prepare training session on flood preparedness at the commune level.

Module 6: Field trip for practice

Please find the detailed outline of the ToT curriculums in **Annex 3.D.3** for reference. A total of 300 copies of curricula were printed and distributed to the target provinces, districts and Provincial Red Cross and NGOs working in Tien Giang and Ben Tre provinces.

Prior to the ToT development, personal from World Bank, provincial Red Cross, DDMFSC, Tien Giang officials who were trained by the previous phases of the ECHO and GTZ-funded projects and MRC-ADPC project team, were invited to prepare and facilitate the ToT curriculum.

Based on the developed curricula a 3-day refresher training course was organized on 10-12 April 2009 for 12 officials who were trained under the ECHO III phase from Cai Be and Cai

Lay district CFSCs in Tien Giang. Additionally, a 5-day ToT training course was also organized on 2-6 June 2009 for 25 officials from Chau Thanh district of Tien Giang and Cho Lach district of Ben Tre. Those training sessions aimed to;

- i) Establish and strengthen district networks of resource persons for four districts in Tien Giang and Ben Tre provinces,
- ii) Support the implementation of the national strategy of DM to 2020, especially to the implementation of the provincial CBDRM programme in the two provinces.

According to the training evaluation results, the training sessions were successfully conducted in terms of both preparation, and the contents, which met the country's strategic orientation of disaster management. After going back to their districts, the participants will join in commune meetings with PCFSC and DCFSC for preparing commune trainings. Then they will officially work as trainers or facilitators for these trainings. In conclusion, along with the previous TOTs, the training contributed to establishing a complete network of district trainers of all 4 project target districts as a sign of sustainable development. From now on the provinces have their own "on-site" force for their activity of capacity building. It also means that the training is supporting the provinces' implementation of the national strategy in terms of developing local human resource for the field of disaster management.

The training reports are enclosed as **Annex 3.D.3.1 and 3.5.3.2** for detail information.

**Activity 3.3:** Support to conduct commune-level trainings on Flood Preparedness for the Commune DM Committees/Teams by the trained trainers in each of the selected district in Ben Tre and Tien Giang provinces.

#### Achievement of 3.3:

There were a total of 9 commune trainings held with participation of 280 persons from 113 communes in the 4 project districts and one extra district reaching 100% of the project communes.

"Natural disasters do not happen to one or two places, but to all, so capacity building for the districts should cover all their communes, not a single commune" said representatives of the PCFSCs and DCFSCs of the project area. The local authorities also said that storms happen very regularly, so the communities should learn how to deal with this natural disaster.

With the above idea, the activity of commune training under the ECHO IV project was driven to develop a network of human resource by getting involvement of all the project communes and the recent natural disasters.



Immediately after the district level ToT, the trainers were provided guidance and training materials to update and adapt the curricula developed under the previous phases of the ECHO

and GTZ-funded projects that is to be used for the commune level trainings, as well as to further conduct commune level training in their target districts. In addition, a specific module on Typhoon and Whirlwind Preparedness Planning was developed as a request from the provincial CFSCs during the consultation for adapting the curriculum. A total of about 470 copies were printed and distributed to the target districts, provincial and district Red Cross and the NGOs working in Tien Giang and Ben Tre. The Training course curriculum incorporates the following;

- The curricula on Flood Preparedness targeted the commune level officials in implementation the priority activities identified in the commune annual plan for Flood, Storm Control and Victim Rescue;
- The content of this course was focused on household and village level preparedness measures. The content of the course was developed and adapted to suit the local conditions in consultation the District Committee for Flood Storm Control and aimed at developing their skills as trainers and facilitators.

Based on the above Training Course Curriculum, a series of nine trainings were conducted for totally 280 key officials from 113 flood prone communes in the five districts of Tien Giang and Ben Tre provinces. The training course ran as followed:

- 1. Cai Be district Tien Giang: on 23-25 and 26-28 August 2009: A total 60 representatives from 27 commune FSC committees including commune leaders, statistic bureau, women union, red cross, youth union, farmer union, schools and local people, etc.
- 2. Cai Lay district Tien Giang: on 29-31 August and 1-3 September 2009: A total 60 representatives from 30 commune FSC committees including commune leaders, statistic bureau, women union, red cross, youth union, farmer union, schools and local people, etc.
- 3. Chau Thanh district of Tien Giang: on 17-19 and 20-22 August 2009: A total 60 representatives from 26 commune FSC committees including commune leaders, statistic bureau, women union, red cross, youth union, farmer union, schools and local people, etc.
- 4. Cho Lach district of Ben Tre: on 10-12 & 13-15 September and 2-4 December 2009: A total 80 representatives from 16 commune FSC committees including commune leaders, statistic bureau, women union, red cross, youth union, farmer union, schools and local people, etc.
- 5. Looking at the success of the training at commune level, the Ben Tre PCFSC requested the MRC-ADPC project to provide further technical support to conduct further commune level training to Mo Cay Bac district using the revised training curriculum and suggested to share the cost. Hence, one more training for 20 persons of the 14 flood prone communes of the Mo Cay Bac district were conducted on 2-4 December 2009.

During the evaluation/feedback session, it was shared by the participants that the training duration was to short. However on a more positive side it was learnt that the facilitators were enthusiastic and willing to share their knowledge to participants. The participants were also active and concentrated on learning and also discussing the sessions. The training course has helped to increase commune staffs' knowledge on disaster management and disaster preparedness planning better. After the training, the participants have learnt more on the disaster report, dissemination and preparedness planning as well as HVCA in local areas.

In total, the capacity of the 113 communes (280 commune staffs) in Cai Be, Cai Lay and Chau Thanh districts of Tien Giang and Cho Lach, Mo Cay Bac of Ben Tre were enhanced.

**Activity 4.1:** Consultation with provincial and district authorities as well as DIPECHO partners to review existing IEC materials (SFSP kits) and strengthen partnerships for IEC programs for specific hazards in the target provinces.

#### Achievement of Activity 4.1

Thousands of sets of new IEC materials reviewed and produced and distributed broadly



To improve the quality of activities of public awareness, Information, Education and Communication (IEC) materials were shared with the communities and NGOs via the Joint Advocacy Network Initiative (JANI), Vietnam, and the other stakeholders in the project areas for reviewing. Then all the materials more or less were adjusted to improve the quality after the review, before they were finalized. Pre-tests of the new IEC materials took place in the field.

Thousands of sets of the IEC materials were developed and distributed to 90 primary and secondary schools in the provinces of Ben Tre and Tien Giang and participants from national workshops. The IEC materials and some training handbooks were very warmly welcomed by NGOs, the provinces in Mekong Delta, VNMC and DDMFSC at a workshop of implementing the 1002 project of building capacity and CBDRM held by DDMFSC with cooperation with AusAID on 11 Nov 2009.

**Activity 4.2:** Promote School Flood Safety Program (SFSP) through the Department of Education to conduct school activities in the target provinces.

#### Achievement of Activity 4.2

Two SFSP workshops were held for 120 teachers from 59 primary and secondary schools

- and 60 SFSP campaigns for 37,132 children, teachers, parents, commune staff in the 4 project districts in Tien Giang and Ben Tre.
- Two billboards of 3-step flood management were installed.
- One SFSP partnership workshop was took place in participation of MOET, students, and with student's support for MC.

#### SFSP workshops and SFSP campaigns

#### • Objectives

- General: support for implementation of the strategy and the 1002 project of capacity building and CBDRM.
- Specific: strengthen and raise public awareness on FSC for all the 4 project districts.

#### • Duration and time

- SFSP workshops: one-day orientation workshop for school teachers, held in February and March 2009.
- Festivals of SFSP Day: one-day festivals, held before summer holidays before May 2009.
- SFSP Partnership Workshop: one-day workshop, held in 9 October 2009.

#### • Approach and participants

- The program was implemented through the education system of schools in which the schools were expected to work as IEC centres and their children as effective communicators.
- There were 2 SFSP orientation workshops held for 160 teachers from 59 primary and secondary schools in the 4 districts of Cai Be, Cai Lay and Chau Thanh in Tien Giang and Cho Lach in Ben Tre. These workshops were conducted by the line agency of provincial DoET.
- There were 59 festivals of SFSP Day held with participation of 37,132 persons including children, parents, commune staff and representatives from district/province line agencies. The festivals were carried out by the schools under coordination and guidance from the district DoET and technical support from the project.

#### • Outline of SFSP program:

- (1) Orientation workshops for teachers.
- (2) School meetings to share lessons learnt from the orientation workshops to other teachers.
- (3) Class meetings for children.
- (4) Festivals of SFSP Day at schools



- (5) Children work as effective communicator at home and in their communities after festivals of SFSP Day.
- (6) Experience documentation for officially integrating the program into the main stream of education and training curriculum.

#### • Description

*Key activity of orientation workshops:* 

- 1) Speeches of line agencies,
- 2) The national strategy,
- 3) Introduction of the SFSP program,
- 4) Orientation of school meetings for teachers and children, orientation of SFSP Day,
- 5) Using IEC materials,
- 6) Discussion and experience sharing of flood and adverse impacts,
- 7) Practice preparedness components of FSC for schools.

### Activities of SFSP Day:

- 1) Watching film 'Living with Flood'
- 2) Answer and question, Role play Emergency task during flood
- 3) Singing, and sharing of flood stories
- 4) Painting competition about flood preparedness
- 5) Drawing flood map
- 6) Making a raft, and exhibition of floatable devices for in flood safety
- 7) Sharing paintings on floods
- 8) Parents interaction with children
- 9) Rewards to excellent children who have shown a good understanding and eagerness in the sessions.

By the end of the project the provincial authorities of Ben Tre suggested that the public awareness activity should be a priority activity of Cho Lach district for its FSC preparedness. This suggestion was considered as a way to support the implementation of the national strategy and the 1002 project.



As the priority activity for Cho Lach district, two billboards of 3-step management for house level were designed and installed in the areas where are the most impacted by annual floods.

### School Flood Safety Program (SFSP) Partnership Workshop held

A SFSP partnership workshop was held in participation of children and line agencies from Ben Tre, Tien Giang, An Giang and Dong Thap, the national partners and MOET.

Children were not the only the target group, but also the partners who had joined the MRC work and discussions.

#### • Introduction

The provincial partnership workshop for school flood safety was jointly-organised by Tien Giang Department of Education and Training (DoET) and the Provincial Committee for

Commission Secretariat (MRCS) and the Asian Disaster Preparedness Center (ADPC) with funding support from European Commission Humanitarian Aid Department (ECHO).

The workshop was honourably participated in by representative of Vietnam Ministry of Education and Training (MoET), MRCS, Vietnam National Mekong River Commission (VNMC), Department of Dyke



Management – Flood and Storm Control (DDMFSC), provincial and district line agencies, educational sectors such as Department of Education and Training, school teachers and children. Neighbour provinces such as Ben Tre, An Giang and Dong Thap also participated to share ideas.

"It is very appreciated to hear that Tien Giang, Ben Tre and other provinces in Mekong delta with support from the project have taken the initiative of this integration. Hoping that the SFSP program can be adapted for allthe Mekong delta and the country as well" – said by Mrs. Nguyen Thi Son – Ministry of Education and Training.

### • Objectives

- Consolidate the experiences and lesson learnt from the School Flood Safety Program since 2007 in the Mekong Delta.
- Activate the existing provincial partnership to further conduct child safety awareness programs in the schools by the teachers as part of regular activity of the school.

#### • Duration and time

It was a one-day workshop that held on 9 October 2009.

#### Approach and Participants

The workshop was held by Tien Giang province through its education system with support from the national level.

There were 69 persons joined the workshop including children, teachers, and representatives from DoETs and other line agencies such as Military, Police, Red Cross, Women's Union from the 4 provinces of Tien Giang, Ben Tre, An Giang and Dong Thap, and the national partners VNMC, DDMFSC, and especially MoET.

At the workshop the children joined in the work of MC, joined in the activities of group working, and shared their ideas and thinking to improve the SFSP program. They were not only a target group, but also a partner.

- The participation of children in the activities of MRC work and discussions turned the workshop into a special event.
- With the topic of disaster management integration into the school system and the participation of MoET the workshop became the first event of its type, in the Mekong delta.
- The workshop was highly evaluated by MoET, the national-level project partners, VNMC and DDMFSC and the regional partner MRC as it was in according with the national strategy and the objectives of the project. It was said that the workshop was a very successful one and left a strong impression.

#### • Workshop activities:

- 1) Speeches of line agencies, partners and MoET,
- 2) Evaluation and experience sharing of the current SFSP program
- 3) Maintaining the SFSP program and developing provincial partnerships on child safety.

#### • Discussion notes as next steps

- ➤ NGOs and line agencies should cooperate to develop a unique set of IEC materials and handbook.
- ➤ Besides flood, the contents of the IEC materials or hand books should combine other disasters such as storms, whirlwind, etc.
- ➤ The SFSP program and the workshop were good practices that should be adapted to all the provinces in the Mekong delta.
- ➤ The role of a friends participating together in the events was very popular and provided good motivation and enthusiasm for the children, so should be maintained to improve the quality of the program in the future.
- > IEC materials or handbooks should be delivered in greater volumes so that each child can own one set of these materials
- ➤ The photos/picture of the IEC materials and handbooks should be larger, but with less words, and should be adapted to the class children's level.

In conclusion, the public awareness activities have been well and widely carried out in the country. The impact of those activities is not limited within the border of the two target provinces but also spread to others in Cuu Long Delta and reached up to the national level. The

modals and approaches of carrying out the public awareness and IEC materials which have been updated and adapted to the local contexts have been well accepted and highly appreciated by the local authorities and communities. A huge amount of IEC materials were widely distributed in and out the country through any opportunity that ADPC project team members participated in any event. Though out of this particular activity, the partnership and cooperation between ADPC and local authorities and NGOs had also been strengthened.

Together with the Ministry of Education and Training (MoET) and NGOs, such as Save the Children, the SFSP has been initially integrated into the school curriculum. However, it is still in the process of integration into the extra-curricular activities. It still needs to be promoted further with the education sector in order to fully integrate it into the school curriculum.

Considering all activities and accomplishments as a whole, this activity has been supporting the government in implementing their National Strategy on DRR very well, particularly, it has been supporting them in preparation and implementation of the National Programme on CBDRM that will be to implemented in 2010. For instance, the project products, materials and implementation modals and approaches related to CBDRM have been used by the government for development and preparation to implement the National Programme on CBDRM.

• Activity 5: Promote national level knowledge sharing on Flood Preparedness Programs in the Lower Mekong Basin and mechanisms for future programming of MRC FMMP

Activity 5.1: Documentation of good practices on Flood Management and Mitigation in the Lower Mekong Basin.

The activities of training and public awareness, for example; the provincial trainings; festivals of SFSP Day; and the SFSP partnership workshop under the ECHO IV project, had been shared at the national workshop between the partners, via JANI and the network of the Disaster

Management Working Group (DMWG). The newsletter of the SFSP partnership workshop at **Activity 4.1** is an example.

*Activity 5.2:* Conduct a National Flood Forum before the MRCS Annual Mekong Flood Forum. The objectives of the national flood forum would be to promote knowledge and information sharing on flood management and mitigation in the Lower Mekong Basin and the contribution of the Flood Preparedness Programs in development of the future program of MRC-FMMP

#### Achievements of Activity 5.2

A public private partnership workshop was held - A step ahead for Flood Risk Reduction in Viet Nam.

Promotion of Partnership between Public-Private Sector and Vulnerable Community in Flood Risk Reduction in the Cuu Long Delta

Promoting Community – Business Partnership in Flood Risk Reduction in Mekong Delta was rather a new but innovative initiative which was expected to get public and private companies involved.

The flood preparedness and response priorities identified by the provincial and district authorities such as community based flood management, search and rescue, emergency kindergarten and a universal swimming program for school children has strengthened capacities of local disaster management authorities in dealing with floods. This had also contributed to the overall principle of 4 on-site motto promoted by the Vietnam Government

Public awareness to promote "Living with Floods" concept had gained a new ground with traditional and innovative approach in reaching out communities at risk. Traditional performance, public awareness materials, e.g. posters, booklet, bill boards, etc. became effective communication means in conveying flood risk reduction measures to people in the Mekong Delta. However, the preparedness, prevention and rehabilitation stages had not been paid sufficient attention. Therefore this should be a focus of future projects and activities by using public awareness raising activities and training and capacity building before disaster.

The National Forum on "Promoting Partnership between Public-Private Sector and Vulnerable Community in Flood Risk Reduction in the Cuu Long Delta" was held in Ho Chi Minh city on 1 December 2009 with the aims of:

• Establishing a bi-lateral cooperation between public - private sector and government in order to bring about benefits to both partners while contributing to disaster management in Mekong Delta more effectively (with a focus on the long term strategy).

- To encourage the support and cooperation of private and public companies in flood preparedness and prevention activities in the Cuu Long Delta;
- To explore key policies, legal and institutional issues regarding private-public partnerships in Cuu Long River Delta;
- To propose emergency flood risk reduction activities which needs support from the partnership to minimize losses of life and properties caused by flood and create better condition for sustainable socio-economic development.

The Forum was chaired by Pro. Dr. Dao Xuan Hoc – Vice-president chief of the CCFSC, Vice Minister of the Ministry of Agriculture and Rural Development (MARD) with more than 60 attendants from MRCS, VNMC, DDMFSC, VCCI Ho Chi Minh, Can Tho and Vung Tau, Cuu Long Delta provincial partners, public and private enterprises, mass organizations such as Women's Union and Red Cross, non-governmental organizations (NGO) and mass media. The Forum emphasized the fact that hydro-meteorological disasters such as flooding, storm and extreme droughts coupled with the impact of climate change have increased in the recent years in the Cuu Long Delta. The recent examples of emergencies have further emphasized the need for a multi-stakeholder approach in disaster risk reduction in line with the objective of the Vietnam National Strategy for Natural Disaster Prevention, Response and Mitigation to 2020.

The public and private enterprises in Vietnam under the Vietnam Chamber of Commerce and Industry (VCCI) have been supporting vulnerable community during emergency response, whereas disaster preparedness and involvement of private companies is needed to create an enabling environment to achieve the objective of the National Strategy for Natural Disaster Prevention, Response and Mitigation to 2020.

The partnership between public/private sector and vulnerable community has been one of the important agenda with the Department of Dyke Management and Flood Storm Control (DDMFSC), where the public and private enterprises can extend their involvement in capacity building, public awareness raising, preparation of the community flood preparedness plan, disaster risk assessment, etc, in order to help community increases their own resilience to flood. In return, enterprise image will be highly promoted in front public and community.

Mr. Huynh Duc Tam, General Director of the Construction Investment and Consultant Co., said "it will be good if private and public companies should be involved and support local authorities and communities in the process of disaster management from the beginning to the end. The government should have some preferences for those businesses that offer support, so that they are more motivated to participate".

Provincial participants shared that there are many good disaster management models in their provinces but it is limited in some communes and many training materials and IEC need to be revised to be more suitable to the local needs and practices. They said that this Forum is a very good idea for them to involve businesses in disaster preparedness by asking for their support financially. Their logos and images will be acknowledged as a donor of disaster risk reduction for the community. It is the intention that the total of money they donate will be less than what they receive from the branding and advertisement of their company in a community, so as well

as providing a valuable service for a community the business itself will also benefit, making the venture very attractive to participate in.

The Vice-Minister, Prof. Dr. Dao Xuan Hoc said that "... MARD will take this partnership issue into the development of the disaster management laws and into the development of the yearly implementation plan of the nationwide program on CBDRM. Such partnership will be further promoted during the program implementation course that to be started next year"

An action plan for possible areas of cooperation between the disaster risk reduction initiatives taken by CCFSC and the VCCI was formulated to contribute to minimizing loss of life and property, creating a better environment for sustainable socio-economic development. These cooperation's are skilled in the area capacity building, public awareness raising, preparation of the community flood preparedness plan.

The partnership between public and private organisations and the community on disaster risk reduction has traditionally been practiced in the country. However, it has not been fully integrated into disaster risk reduction yet. Creating a room for every concerned partner to discuss and bring the issue, and greater support from government in strengthening this approach should be the main aims of this initiative. Promoting such partnership in Cuu Long Delta may be considered as a pilot for the future expansion of the initiative.

# E. Partners and Beneficiaries

This was a regional project supported by ECHO to strengthen the disaster preparedness interventions at the province, district and commune levels. The Mekong River Commission and its National Mekong Committee give utmost important to the contribution of European Commission (EU) through ECHO in supporting the MRC's Flood Management and Mitigation Program (FMMP) in achieving its goals through this project.

While the ECHO office has signed a Contribution Agreement with the Mekong River Commission (MRC) for implementation of the project activities identifying the Asian Disaster Preparedness Centre (ADPC) as implementing partner of MRC through a Grant Agreement. The MRC and ADPC have implemented the project within the framework and institutional arrangement of the Flood Management and Mitigation Program (FMMP) closely linking to the Component 4 – Flood Emergency Management Strengthening (FEMS). The project has contributed in achieving the goals in the national disaster management strategies of the target countries. And the National Disaster Management Offices (NDMO) through its Provincial, District and Commune DM office has worked as an implementer having played an important role in implementing the activities and linking it within the overall framework of the National, Provincial and District DM planning and policies.

### I. European Commission Humanitarian Aid Department (ECHO)

ECHO had meetings with MRC, ADPC and other partners during the last period for consultation regarding implementation.

### II. Mekong River Commission (MRC)

The Mekong River Commission Secretariat through the FMMP team based at Regional Flood Management and Mitigation Centre in Phnom Penh is the implementing agency on behalf of EC. The MRC has worked through the NMCs under the 1995 Agreement to coordinate operations in the riparian countries. MRC has provided all technical help in implementation of the project as well as support through the National FMMP Coordinator based in the NMCs.

Service of the National FMMP Coordinators was ensured by MRC. As resulted, the National FMMP Coordinator facilitated coordination among the MRC-ADPC project staff and the national, provincial and district DM authorities and line ministries in implementation of project activities. They participated and provided inputs in monitoring and evaluation of the project activities.

The detail Implementation Plan of project activities and Quarterly Activity Work Plans were sent to VNMC respectively by MRCS and FMMP team in according to the project documents.

### III. Asian Disaster Preparedness Centre (ADPC)

ADPC has signed Memorandum of Understanding (MoU) with the NDMOs of Vietnam in implementation of project in the country.

During the last phase of the project, ADPC has worked further with the MRC, NMCs as well as the NDMOs and its provincial and district level DM committees in implementation of the project activities. The following staffs of the ADPC have been responsible for smooth implementation of the project activities as per the work plan. The DMS team member has provided quarterly work plans to MRCS via the responsible FMMP Programme Officers by two week before the quarter.

### IV. Vietnam National Mekong Committee (VNMC)

The project activities have been coordinated in close collaboration with the senior officials of the VNMC. The head office of VNMC based in Hanoi, as well as its Southern Representative office in HCM has been well involved in coordination and implementation of the project activities. The VNMC, through its official communication to the Department of Dyke Management and Flood and Storm Control (DDMFSC) People Committee of Tien Giang and Ben Tre has been informed and has provided consultations to implement the activities. Both the FMMP Team (MRC) and DMS Team (ADPC) have reported and updated the progress to the VNMC on regular intervals, and souk their guidance on proper implementation arrangements and help in operational matters. The senior officials of VNMC are planning their visits to the project sites in May.

### V. Department of Dyke Management Flood and Storm Control (DDMFSC)

DDMFSC Southern Office has been signed for implementing the project and worked effectively as an implementer and a national consultant for the project.

The manager and senior staff of this office have offer regular visit to the project sites. The project has been quickly promoted by DDMFSC Southern Office.

### VI. Provincial Committee for Flood and Storm Control (PCFSC)

The Department of Agriculture and Rural Development (DARD) signed the Water Resource Department as the focal point for this project.

The other lines agencies such as the Department of Planning and Investment, Department of Education and Training (DoET), Committee for Population, Family and Child (CPFSC), Department of Information and Social Welfare along with the Vietnam red Cross (VNRC) and its provincial office and mass organizations, particularly the Women Union and Youth Organisations, who had an important role in implementation of the project activities were invited to the very first meeting of the project. During the last period of the project (mainly the last two quarters of 2009), VNRC and DoET joined effectively in implementation of the training activities and School Flood Safety Program (SFSP).

The Department of Agriculture and Rural Development (DARD) was responsible for communicating the activities to the target district officials and reporting on the progress of the project to the Peoples Committee officials, as well as mobilizing support from them. As discussed with DARD, the focal points at the provincial and district level were identified with clear roles and responsibilities and have well functioned.

The project in the last three phases since 2003 (ECHO phases I, II and III) under three separate DIEPCHO South East Asia (SEA) action plans, made efforts to build on the progress of the previous phases, as has happened in ECHO phase IV. The provincial, district and commune level authorities played an important role in implementation of flood preparedness measures, and all was linked well with the overall framework of the National, Provincial and District DM planning and policies.

The current project provided a good opportunity to showcase some of good examples of flood preparedness measures, mainly;

- ➤ The School Flood Safety Program (SFSP)
- Public Awareness Raising strategies in the Mekong Delta
- ➤ The involvement of the public & private partnership in Flood Preparedness
- Commune level capacity building
- ➤ The effective implementation of the Flood and Storm Control plan (FSC) in provinces and districts.

This was all achieved by fostering partnerships, and building the confidence of the provincial authorities, and enabling all the stakeholders to work effectively with little money and a fixed time frame.

#### VII. Focal Points at National, Provincial and District levels

MRC and ADPC worked very closely and are responsible for successful implementation of the project activities. The participation of the Vietnam National Mekong Committee (VNMC) as well as the Department of Dyke Management and Flood Storm Control (DDMFSC) in the project implementation and progress monitoring ensured achievement of the high quality delivery and high coverage in each of the planned activities. The VNMC, particularly the National FMMP Coordinator, provided kind support to the project activities by coordinating with PCFSC, DoET as well as with the FMMP team. The following focal points were identified in the beginning of the project and contributed in successful implementation of the project activities.

### F: Progress Reporting, Monitoring and Evaluation

MRC with ADPC were responsible for documenting all the outcomes of the project and sharing with the local and national partners regularly. Regular monitoring of the project activities were carried out by VNMC with the help of the Provincial Focal point and the Project Team. During the FMMP PCC meeting, progress was reviewed and suggestions were incorporated to ensure quality implementation.

At the MRCs level, the FMMP Program Coordination Committee (PCC) meeting took place every quarter. During this project implementation since August 15, 2008, six PCC meetings took place where project progress was reviewed. The Program Officer of FMMP responsible for the reporting of all the progress to the MRCS secretariat, the Donors, the FMP senior management team etc. ensured regular sharing of progress through email as well as presentations during the review meetings. The achievement of the ECHO III project were reported regularly in the biannual report prepared by FMMP which goes to a wide range of stakeholders from national and provincial authorities, experts, donors and partner agencies.

In addition, during this project implementation, the FMMP Program Office (focal point for this project) is updating the current progress, and seeking further input, to the TA at the ECHO Regional office as well as the Desk Officer at ECHO Brussels office.

At ADPCs level, the Project Manager, Project Coordinator and the Project Associate worked closely with the DMS Team Leader and Director and other ADPC staff for better implementation of the project activities and reporting of the activities at different forums at

regional and international levels. In the field, ADPC project staff and the MRC project staff worked closely with the national and provincial partners in the activity implementation and progress updates. The DMS Director and Project Manager at ADPC provided the project progress update to the Executive Committee of ADPC and also to the Board of Trustees.

The Regional support office of ECHO in Bangkok was regularly being updated about the progress and informed of any difficulties in carrying out the activities. The ECHO Regional Support Office (RSO), particularly the Technical Assistant and the Program Assistant, provided a lot of support by sharing information from the other projects under DIPECHO as well as by participating in some selected project activities.

During each visit to the province, the MRC-ADPC team had meetings with senior officials of National Disaster Management (DM) offices and the National Mekong Committee to update the current progress of the project. In addition, the project team also encouraged the Provincial focal point to send progress updates as well as problems in implementation to the National DM offices. Such coordination and monitoring ensured a high level of achievement as well as a sense of ownership of the project within the local authority.

As planned under the project, several Monitoring and Evaluation (M&E) meetings (in addition to the progress review meetings mentioned above) and field trips took place. One of the meetings was a visit of representatives of ECHO regional office in Bangkok, MRCS/FMMP Programme Officer and VNMC, DDMFSC to Tien Giang and Ben Tre on October 9 2009. By this time the representative also joined in the SFSP Partnership Workshop in Tien Giang. Based on the talks with the provinces on October 9<sup>th</sup> and the workshop on October 10<sup>th</sup>, the representative evaluated highly the implementation of the project. A trip report of the meeting by a representative of MRCS is enclosed as **Annex 3. F** 

At the end of the project, an end of project evaluation report, by an external consultant to assess the overall impact of the project, and to provide guidance for a s for future years.

The evaluation would be shared by the Consultant with the MRCS as the report is under preparation at the time of writing the report.

### G: Linkages with other Projects and Programs

The project linked with the overall strategy of MRC's FMMP and particularly with the Component 4–Flood Emergency Management Strengthening. In addition, the various other programs of FMMP provided input to this project activity. During the implementation, the experiences of MRC's FMMP were incorporated to achieve the overall goals of MRC and of ECHO under this program.

In addition, the following NGOs provided support and maintained a good relation with the MRC-ADPC project in Tien Giang

- I. Save the Children: save the Children was the DIPECHO partner in Tien Giang province under the current DIPECHO program. Sharing experiences of the SFSP program and reviewing the IEC materials was the main role of Save the Children during the period of ECHOIV.
- **II. World Bank (WB):** WB had been carrying out a project on Community Based Disaster Risk Reduction (CBDRM) in the Cho Lach district in Ben Tre province. The project had cooperation with this organization in the filed of capacity building for CoCFSC on FSC. To ensure no aspects of project implementation over-lapped, the two sides had discussions before the activities took place.
- **III. Oxfam:** Similar to the role of the World Bank, Oxfam has also been implementing a project of 'livelihoods adapting climate change' in the region. The project had meetings and exchanged IEC materials with Oxfam in the field of public awareness of Disaster management.
- **IV. UNDP:** One of the activities of a current project funded by UNDP to DDMFSC was to identify the training needs for disaster management in Viet Nam. The project team took a number of meetings with the UNDP project unit to share and exchange related information and materials
- V. Joint Advocacy Network Initiative Vietnam (JANI): is consisted of 14 NGO members in Viet Nam including CARE International as the focal point for this ECHO-funded project. ADPC is one of among these members. Therefore there was very close consultation and information sharing throughout the project implementation between the project team and JANI Vietnam.
- VI. National Programme on CBDRM: As mentioned above, the project has directly contributed to the implementation of the National Programme on CBDRM, especially to the implementation of such programme in Cuu Long delta.

### STRENGTHENING PROVINCIAL CAPACITY ON FLOOD AND STORM CONTROL PLANNING IN MEKONG DELTA

(Cyposition by analysis of the second second

A 4-day consultation cum provincial training workshop on "Strengthening Provincial Capacity on Flood and Storm Control Planning" was held on 09-12 June, 2009 in Ben Tre Province. This event was jointly organized by the Ben Tre Provincial Committee for Flood and Storm Control (PCFSC), Mekong River Commission Secretarial (MRCS) and Asian Disaster Preparedness Centrol (ADPC). This activity is a part of the ongoing DIPECHO 6th Action Plan project with funding support from the European Commission Humanitarian Aid department (ECHO).

Ben Tre is among the Southern provinces in the Hekong Delta that has prepared both the Provincial Disaster Management Action Plan for the implementation of the National Strategy in October 2008 and Annual Flood and Storm Control Plan 2008-2009. These Plans outline preparedness and readiness of the PCFSC and its members in dealing and response to natural disasters.

The workshop and training focused on detailed consultations among the PCFSC members on the implementation of the Provincial Action Plan, enhancing skills of the members of line agencies in better implementation of flood and storm control annual plan as well as coordinated efforts on a multi-stakeholder action plan for Ben Tre province in implementation of National Strategy for Natural Disaster Prevention, Response and Mitigation to 2020 as directed by the Central Committee for Flood and Storm Control.

A total of 74 participants were drawn from Ben Tre province and its 09 districts, who are the member of the Provincial and District Flood and Storm Control Committee. In addition, representatives from the Department of Dyke Management and Flood Storm control (DOMFSC), Hedong River Commission Secretariat (RMSCs), Verleam Melong Committee (VMNC), Verleam National Red Cross (VMRC), Asian Disaster Preparedness centre (ADPC) and neighboring provinces of Tien Glang, Dong Thap and An Glang participated as observers and resource persons.

The consultative and training workshop was divided into two sessions as follows:

 To share knowledge, experiences and lessons learnt in development and implementation of Provincial Action Plan in line whe heatinnal Strategy for Matural Disaster Prevention, Response and Mitigation to 2020. This also involved the identification of difficulties and challenges of each province in developing and implementing the Plan.

 To strengthen capacity of PCFSC and its line agencies on Flood and Storm Control planning and implementation. Besides providing basic knowledge on natural disaster and skills on planning and implementation, participants were provided a practical assignment on making their own sectoral development plan with the integration of disaster management plan

In the workshop, participants discussed and shared experiences on the implementation of Provincial Action Plan in line with the National Strategy to Natural Disaster Prevention, Response and Hitigation to 2020. Representatives of Ben Tre, An Glang and Dong Thap province shared experience on how they developed their provincial action plan and also expressed some concerns such as limited resources, technical capacity and experience, that contributed to their not being able to implement the Provincial Action Plan perfectly according to the outline of the Hational Strategy to 2020. In addition, a discussion session on the integration of natural disaster management into sectoral plan and local development plan was also facilitated.

The resource persons from DDMFSC, MRCS, VWRC, VWMC and representatives from the provinces shared experiences on the feasibility of a Provincial Action Disaster Hanagement Plan. It was learnt that local authorities role in enhancing effectiveness of operation and management; concretizing the action plan; combining synchronously non-structure and structure measures is very imporant. However, besides financial support from the government, local authorities should mobilize resources from their own community, prioritizing structural activities and strengthen capacity of warning system and awareness raising campaign for schools children and local community.

During the four days, participants showed their great interest in the training and found it useful to their duties towards flood and storm control planning and the integration of disaster into sectoral plan as well as into the provincial socio-economic development plan. They were given an opportunity to have direct discussion with national and local agencies on how to better develop and implement provincial action plan in line with the National Strategy to 2020.

Most participants expressed their understanding in development and integration of disaster management into sectoral polish. This was proved by their group work on developing sectoral plan during the training, As a follow up of the training, further meeting of the PCFSC would be organized to detail the existing Provincial Action Plan with more detail information on flood preparedness, response and Mitigation. This would be done with the help of small task force from the PCFSC.

### **Executive Summary**

Like other areas of Vietnam, preparedness and implementation of flood and storm control in the Mekong delta has systematically organized into 3 levels – province, district and commune. With the Government's and party's appropriate attention, the flood and storm control has achieved considerable progress in various aspects such as legal framework and direction provision, capacity building and public awareness, infrastructure, forecast and warning, etc.

Further in 2007, the National Strategy for Natural Disaster Prevention, Response and Mitigation to 2020 was approved. According to Natural Disaster Management Partnership (NDMP), based on the progress of one-year implementation of the National Strategy, however, it shows that the implementation is requesting a great effort from the provinces' FSC systems – PCSCSs, DCFSCs and CoCFSCs to achieve the expected outputs of the National Strategy. And it also appears that there is a real need of these systems for being consulted and trained in the relevant field.

The Mekong River Commission Secretarial (MRC) in partnership with the Asian Disaster Preparedness Centre (ADPC) and funding support from the European Commission Humanitarian Department (ECHO) and Deutsche Gesellschaft fur Technische Zusammenarbeit GmbH (GTZ) has been implementing flood preparedness and emergency management strengthening activities in An Giang, Dong Thap, Tien Giang. Under its Phase IV project "Strengthen Implementation of Flood Preparedness Programs at Provincial, District and Commune Levels in the Lower Mekong Basin" funded by ECHO, capacity building activities in Tien Giang and Ben Tre having being taken place in close partnership with Vietnam Mekong River Commission (VNMC) and

Department of Dyke Management – Flood and Storm Control (DDMFSC). Provincial training, TOT training, TOT training and Commune Training are 4 kinds of the activity of capacity building under Phase IV identified

In the beginning of June 2009 a TOT training was held for participants from Chau Thanh district in Tien Giang and Cho Lach district in Ben Tre. #### **ACTIVITY DISCRIPTION**

Based on the 3 parts of the curriculum, the five days of the training were planned into 3 periods: first day, two second days and 2 final days.

### *First day* – 2 June 2009

Base knowdlege of natural disasters and the government's stratergy orientation of disaster management was about the first day

Speeches given by Mrs. Tran Thi Luan Vice Director of DDMFSC Southern Office and Mr. Muoi Vice Director of DARD:

- The important of the project to the provinces and the Mekong delta.
- The linkage of the project to the national strategy of DM to 2020.
- The importance of development of human resources for the districts.
- Role and responsibility of the local persons for the training and implementation of the project: implementation and sustainable development.
- The meaning of the training, role and responsibilities of the participants who will work as district trainers in future.
- Great cooperation and support from the ADPC field office.



Following the opening speeches was a brief of the project and a presentation of The National Strategy for Natural Disaster Prevention, Response and Mitigation to 2020. One of the aspects of the national strategy that was paid a special attention was development of local human resources on DM. Copies of this document were distributed to all the

### participants.

A report of the real situation of natural disasters and flood in the downstream provinces of Tien Giang and Ben Tre and presentations of base knowledge of flood and natural disaster management were introduced to the workshop by the end of the day. Representatives from Ben Tre PCFSC and Long An Red Cross joined in these presentation

### Two second days - 3 & 4 June

Topics of flood management



Overview of flood preparedness planning; Steps of a commune FSC plan; Roles and responsibilities of members of CoCFC for preparing and implementing a CFSCP; Hazard, vulnerability and capacity assessment (HVCA); Preparation for flood early warning, Resource inventory for flood preparedness; Evacuation and safe area management; Public Health in Flood Emergency; Effective implementation of 4 on-site motto; DANA guideline were the topics presented and discussed on the

next two days of the workshop. There were 50 copies of a manual of disaster management for practitioners delivered to the workshop. This manual is an outcome under ECHO III. In addition, a handbook of flood and storm control by CCFSC was also distributed widely to the participants.

Long An Red Cross and Tien Giang PCFSC joined and facilitated for the 2 days.

There were 2 topics that were paid a special attention by the participants. They were role and responsibility of CoCFSC's members in preparing and implementing CFSC plan and how to effectively implement 4 on-site motto.

For preparing and implementing FSCP, besides capacity building, need to increasing role and responsibility of the remembers of CoCFSCs.

Related to the implementation of 4 on-site motto (On-site command, On-site means, On-site logistics, and On-site resources), it was said that the motto could be easily learnt by heart but in reality the implementation of this motto was not much effective and as resulted the communes always looked for support from the higher levels. To increasing the effeteness, it suggest that 4 on-site motto should be

specified in FSCPs.

### Two final days – 5 & 6 June

Training/facilitating skills

Communication skills, facilitating and training skills, materials and project training preparation skills and practice were about the last 2 days. Learning and practice was as the motto of these days.

To create interaction, activeness, brainstorm and increase practice, after each presentation the participants were encouraged and provided chances to join in activities of group discussions and practices.

For practice, there were 2 activities applied. First, prepare and present presentation to the workshop by using PowerPoint files or Ao papers. Second, join a field trip to a commune and learn from remembers of the commune's CoCFSC about planning and implementing FSC.

For long-run support to the local trainers, copies of a second training manual as an outcomes under ECHO IV was distributed at the workshop. It is a training handbook for preparing training materials and practicing training.

Joining a field trip to the commune of My Hiep in Ba Tri district in Ben Tre province – 20 km from Ben Tre city and having a meeting with the CoCFSC was about the last



activity of the training. A Work Bank-funded CBRM project has been carried in this commune. And the trip was accompanied by Mrs. Truc Coordinator of the project.

The objectives of the trip were to develop the trainees' skills of communication, workshop conduction and to provide them chance to learn about CFSCP on the term of CBRM. The trainees

were divided into 2 groups. The group 1 were responsible for conducting the meeting, other for observation and taking notes. Memembers of the group 1 were assigned separated topics at the meeting, such as recent disasters, planning and implementation of a FSCP, involvement of line agencies. They used open questions with sense of communication. However, some of them could not well conduct the meeting that why the meeting sometimes wandered from the subject.

#### IMPLEMENTATION ARRANGEMENT

- In cooperation together, PCFSCs of the 2 provinces worked as the implementer in consultation with VNMC and DDMFSC.
- ADPC played the role of technical support with some support of logistics.

### **COMMENTS**

### Good points

- The training was consulted fully by the national partners as a step of monitoring to keep the activity on the track of the project.

- The training met both of the training objectives and the country's strategy orientation of disaster management- 25 persons from the 2 districts trained and the national strategy to 2020 disseminated.
- The participatory method, activities and time were conducted as planned. The participants were provided chances to join and discuss all the topics/activities.
- Training materials were distributed sufficiently and timely.
- Although Ben Tre province is the new province of the project with less experience in organizing training activities, in cooperation with the province of Tien Giang it tried its best and did a good job for the training

In short, "the training is very well on both of arrangement and contents", said by the participants. However, there were some weak points as listed below that need to be reviewed for next times.

### Weak points

Reviewing the presentations of trainers were limited as some of the presentation were submitted too late to review.

As resulted, one of the presentation was found out of the expected objective. Instead of sharing experience of CBRM, this presentation introduced the CBRM project's activities and achievements. However, it was corrected after that.

### **NEXT STEPS**

- The weak points will be reviewed by the district trainers for their commune trainings later.
- After going back the districts, the participants will join in commune meetings with PCFSC and DCFSC for preparing commune trainings. Then they will officially work as trainers or facilitators for these trainings.

#### **III PURPOSE OF TRAVEL:**

- To join the ECHO Project team's visit to assess the progress of the ECHO project implementing by the MRC in close cooperation with its partner ADPC and local concerned partners in the target provinces of Ben Tre and Tien Giang, Viet Nam.
- To join a SFSP partnership workshop under the ECHO project in Tien Giang province.

### IV. **Objective**:

- The objective of the ECHO project team's visit is to asses the project carried out by the MRC/ADPC funded by ECHO in relation to Community-Based Disaster Risk Reduction (CBDRR) and Flood Preparedness Program (FPP) and to discuss related issues.
- The objective of the workshop is to summary achievements of the SFSP program and

discuss a long-term plan of maintaining this program.

### V. FINDINGS

### ECHO project team's visit

- Due to emergency situation cause by Ketsana typhoon which hit the region, Mr. Thearat Touch was able to participate in only the meeting with the Provincial Committee for Flood and Storm Control (PCFSC) of Ben Tre in the morning of 08 Oct 2009. He has to leave for Cambodia in the afternoon for the immediate mission relating to disaster caused by Ketsana typhoon.
- The PCFSC confirmed that the project started only in January 2009 although it was officially planned to start in August 2008. The delay was reported that because of the delay in signing the agreement between the MRC and the DG ECHO. The PCSFC made a report on the progress made since the beginning of the project up to wend of September 2009.
- They confirmed that capacity building has been raised for the government staff at provincial, district and commune levels.
- In addition, for public and school children, public awareness activities were raised as well at schools and for public so that they can have some knowledge on how to deal with flood and other disasters. It was also highlighted that this activity is the most important in terms of flood preparedness program in the target province and district as school children and public were provided with some important knowledge to manage themselves once flood happens.
- In order to get more participants attending the training workshop, aiming at improving their understanding on flood preparedness program, a cost-sharing method has been applied with the ADPC. It is to note that, some budget has been allocated for PCSFC & DCSFC in Vietnam (different from Cambodia and Laos). In this regard, they believe that it was a good opportunity for them to have their involved staff to improve their knowledge on this matter.
- It was also reported that the in cooperation with PCSFC and DCSFC, the local flood preparedness program has bee integrated into the local development plan.
- One provincial training, one TOT training and two commune trainings were organized for local awareness, preparation and implementation of action plan and flood and storm control plan.
- It was also confirmed that there are two donors for Cho Lach district, ECHO and the World Bank (WB), but no overlap activities between the two donors. The WB activities (started in July 2008 and will end in March 2010) focus on capacity for people and communities (not authorities), while the ECHO project targeting on concerned governmental staff. In addition, the ECHO provides resources person to WB activities through government authorities at provincial, district and commune levels.
- The public awareness activity was organized, attended by 915 teachers, 14,549 students, 1,257 students' parents, 129 staff and 24 partners' representatives. In terms of Emergency Warning System training, the teachers were provided with some orientation, and basic knowledge to respond to flood preparedness provided for school children
- It was also confirmed that the ECHO project is a right project and right action which meet the government's sustainable development strategy.
- It was also recommended that in future capacity building and public awareness should be

- further continued to meet the requirement in the changing world, especially the climate change. This would go along with the national strategic plan 2020. It is expected that by this time 2020 of concerned staff were trained and public awareness on DRR can be reached 70% of population in the province.
- In relation to the disaster preparedness in general and in particular flood preparedness,
  Mr. Komar highlighted the experiences found in Cambodia. The target province of Kratie
  where the flood being affected, based on the flood prepared program and public
  awareness help mitigate the great negative impact to the people. They can first make
  themselves ready for the mitigation before getting support or any assistance from
  outsiders.
- Komar provided the meeting with his childhood experiences regarding floods. He drawn the students' and teachers attention that during flood everyone will look for safe areas, including dangerous or poisonous creatures, such as snakes, scorpions, millipedes, ants, etc ..... Thus we have to carefully check before sitting on something or doing something in such safe area and do not be away from elder people.

### SFSP Partnership Workshop

- Two students took the role of MC.
- More than 70 persons joined the workshop including: representatives from
  - Regional level: MRCS and ADPC.
  - National level: VNMC, DDMFSC and MOET.
  - Provincial level: PCFSC, DOET, Red Cross, Army, Women's Union.
     District level: DCFSC, Red Cross, DOET, teachers and children.
- Exhibition: a lot of drawings, phohos and IEC materials of the SFSP were exhibited, introduced and widely distributed to the participants.
- With support from the project, many and many activities of the SFSP program have been implelemented at schools and quickly bought positive impacts to the schools and the communities. So it should be futher developed and maintained for long-run objectives. The climate change is impacting on all the world in general and Vietnam in particial. The education and training systems will also be suffered from this change. So integration of the SFSP program and disaster management into schooling activities is very needed. And a proper multiple-agency cooperation will help us to deal with it effectively and private sectors should be considered as a highly potential resource (Mr. Tran Quang Tri Deputy of Tien Giang Provincial DOET).
- Relating to the field of disaster and safety, MOET issued many decrees, such as Decree
  458 School Safety and Decree 40 Student Friendly and Active. With the present natural
  disasters in Vietnam and the climate change in the world, an official intergration of
  disaster managerment into the education and training systems is being oriented by
  MOET.

It is very appreciated to heard that Tien Giang, Ben Tre and other provinces in Mekong delta with support from the project have taken the initiative of this

integration. Hoping that the SFSP program can be adapted for all the Mekong delta and the country as well (Mrs. Nguyen Thi Son Representative from MOET).

- SFSP program report: One SFSP orientation workshop for 60 teachers from 30 schools were held. And 30 SFSP Days were carried for 30 schools with participation of 16,632 students, 1,131 teachers and 2,293 parents and representatives from line agencies were organized. 1000 set of IEC materials were delivered (*Mr. Dang Van Hung Manager of Primary School Department*):
- 4 experiences of SFSP program: 1) Meeting rightly needs. 2) Mobilization and development of involvement 3) Integration into loca activities 4) Suitability of IEC materials (Mr. Bui Trong Nghia National Trainer under Vietnam Red Cross)
- The program is very useful. In fact, the program is what the schools are looking for. So SFSP Program should be reviewed and maintained for long-run, said by a teacher.
- A role-play Far-Sightedness about prevention of flood and storm was showed by children. The children said that they learned and experienced much about 3 steps of flood management of school and household.
- At the Provincial Partners Workshop, many students attended clearly mentioned that they were invited to the meeting so that they can improve their understanding of flood. After this meeting they may share such understanding with their friends. They students actively discussed in their group discussion
- With the program, *children* is not only the target group but also important and positive *partners* as they can work as effective communicators and give useful advises (Mr. Tran Van Binh DDMFSC).
- Discussion 1: What things can be done to improve and maintain the SFSP program? *Children*:
  - Provide a swimming training activity to living with flood.
  - Provide a handbook of swimming.
  - More and more games to have more fun.
  - Should put more questions and more study cases.
  - Should have more activities of flood safety.
  - Each of child should be provided a life-jacket. Especially for the ones who have to go to school by boat or have to pass ferries.
  - To creacte SFSP days more fun, should have more acts of singing and dancing.
  - Provide information and images from abroad to learn.
  - Establish a group of communicators for each school for dissemination.
  - Would like to be joined annually.
  - Would like to have a separated hour for learing, not integrating.
  - Should be officially integrated into the school curriculum.

#### Others:

- Should have a fixed time for SFSP Days. Should be in August when rainy season is.
- Often integrate into relevant lessons.
- Held group learning.
- Materials should provide up to 50% of the numbers of the classes.
- Organize interaction activities with other schools in other districts and provinces.

- Should provide swimming lesson training to children.
- Establish a public awareness club of natural disaster.
- Provide equipments for the program, such life-jackets, flashlight, stretchers, tents etc.
- Stabilize the budget.
- Organize maneuvers of flood management.
- Increase involvement of line agencies.
- Intergate into the activity under Decree 458 School Safety.
- Discussion 2: How can a textbook of natural disaster be prepared to intergrate SFSP Progrma into the school education.

#### Children:

- The pictures of IEC materials should be more multiple-color and bigger
- The photos should be arranged in accordance with the 3 steps of flood management Befor, During and After.
- The photos should be simple and binded up to use easily.

#### Others:

- Besides flood, IEC materials should mention about storm, whirlwind and other natural disasters.
- Should developed in various levels such as grap1, grap 2 or primary and secondary schools.
- The contents and technical terms should be reviewed accordingly.

#### IV. CONCLUSION

#### ECHO's visit

- The ECHO representative appreciated the positive impact of the project in the target province of Ben Tre. He further acknowledge the importance of the recommendation raised in terms of the importance of capacity building and public awareness.
- He was also clarified on the linkage between the ECHO and WB projects in Cho Lach district, Ben Tre province, stressing that they are complement each other in the target district.
- The PCSFC mentioned that they have limited fund, but it would be a good opportunity for the staff to improve their concerned knowledge when there is any workshop organized by donor. We may then send more staff to the workshop through some cost-sharing practice.

### **SFSP Partnership Workshop**

- The progam has receved a very great support from all the participants, representatives of national level and local level as well.
- The program will be improved and maintained for long-run objectives as it is in the right direction of the country in general and MOET in particular.
